MEMBERSHIP INFORMATION
Conditions and Rules

1. New member can terminate their membership agreement with written notice (preferably with a reason) during the first 48 hours of signing up (cooling off period).

2. A new member has the opportunity to read the membership conditions and rules, and inspect the Centre prior to signing up. All agreements must be in writing and disclosure of full fee structures will be given.
3. Complaints are to be handled using both Councils' and the Fitness Code of Practice guidelines. Breaches of the Code should be directed to Beatty Park Leisure Centre and only referred to the DOCEP where they have not been resolved to the client's satisfaction. A copy of each complaint will be placed on file. A response indicating the complaint has been received will be made within 7 days.
4. Members receive a signed copy of the agreement/conditions and rules of membership for the Centre immediately upon joining. The agreement includes the date and time on which the cooling-off period starts and ends.
5. Full memberships are restricted to persons aged 16 years & above.
6. Members must have their membership card, key fob or wristband to gain entry to the Centre.
7. All members are required to have their photo taken at the Centre. This image will appear on the membership database for identification.
8. A fee will be charged for a replacement card, key fob or wristband should you lose your membership card, key fob or wristband or wish to update it. Members that are renewing/ upgrading their membership are required to retain their original membership card.
9. Memberships must be suspended prior to any absence by completing the Membership Suspension Application Form. Membership cards are deactivated during the suspension period. Minimum suspension period is one week (7 days). There is no suspension option for one month memberships.
The maximum suspension time for other members are:

Direct Debit	=	8 weeks (per calendar year)
Direct Debit FIFO	=	4 weeks
3 months	=	2 weeks
12 months	=	8 weeks.

 - No backdating of Direct Debit suspension
 - Minimum 5 business days notice in advance for direct debit suspensions
10. Refunds are not available on memberships, however extenuating circumstances will be considered. Any refunds will be at the discretion of the Centre Manager. Requests for refunds should be made in writing to the Centre Manager. Should a refund be granted, Beatty Park Leisure Centre will deduct any portion of the membership used, plus an administration fee of 20% of the total refund of the membership.

DIRECT DEBIT- CONDITIONS OF AUTHORITY

11. I understand that the City of Vincent (Beatty Park Leisure Centre) accepts this order only upon the following conditions, namely:

I/We authorize you until further notice in writing to arrange for funds to be debited from my/our account described in the schedule above at the financial institution identified, any amounts which the City of Vincent (Beatty Park Leisure Centre) may debit or charge through the Direct Debit/ Credit Card System.

The Financial Institution may be in its absolute discretion, determine the order of priority of payment by it or any moneys pursuant to this request of any authority of mandate.

The Financial Institution may, in its absolute discretion, at any time by notice in writing to me, terminate this Request as to future debits.

The City of Vincent (Beatty Park Leisure Centre) may, by prior arrangement and advice to me, vary the amount or frequency of future debits.

Funds will be available to meet such periodical payments at such time or times as they fall due.

The City of Vincent (Beatty Park Leisure Centre) is under no obligation to debit the account on the days nominated above, and may, at its sole discretion debit the account on any other day that nominated as the day for debiting the account.

The administration fee must be paid at the time of joining.

THIS AGREEMENT WILL CONTINUE FOR 12 MONTHS ON A STUDENT/PENSION DISCOUNT, OR 6 MONTHS ON A FIFO DISCOUNT, or until either you or the supplier terminates it in the way described in the agreement. If the automatic debit arrangement is in place, membership fees will continue to be debited from your credit card or account for a maximum of 12 months or 6 months or until you or your fitness centre cancel the arrangement notifying your bank or credit provider. If you terminate the agreement, then you may be liable to the fitness centre for damages for breach of contract.

Monthly payments will be debited in full when due up to the date of cancellation of membership.

All other agreements will continue until either you or the supplier terminates it in the way described in the agreement. If an automatic debit arrangement is in place, membership fees will continue to be debited from your credit card or account until you or your fitness centre cancels the arrangement by notifying your bank or credit provider. If you terminate the agreement or stop the automatic debt arrangement in a manner not described in the agreement then you may be liable to the fitness centre for damages for breach of contract.
